We Will is a national 501(c)(3) nonprofit organization dedicated to sexual assault prevention and survivor empowerment. The organization was founded in 2019 based on a study founder Brittney Herman conducted during her time in law school at Brigham Young University Law School. The study found that sexual education could be prevented through sexual education. Brittney, seeing no other organization working on prevention through education, decided to start her own.

WE WILL'S MISSION: "We Will prevent sexual assault and empower survivors through formal and informal education, community growth, and survivor support."



PRONGS OF WE WILL'S MISSION:

Formal Education

We Will works across its state chapters to mobilize volunteers and concerned citizens to encourage legislative and educational change to incorporate sexual assault prevention education into public schools.

Informal Education

We Will provides presentations to colleges and universities, mental health professionals, K-12 Schools, youth groups, and parental groups, and provides education regarding sexual assault prevention and survivor empowerment on social media channels.

Community Growth

We Will through community events raises awareness of assault as well as change the narrative surrounding survivors of assault. It strengthens survivor resource centers through fundraising and alters community thinking surrounding these concepts to create a culture intolerant of sexual assault.
